
Government has now proposed to sell the 2246 semifinished flats on "as is where is" basis by grouping them into Cluster / Towers.






Civic 1 BHK 545 Sft. West Facing







The Towers of 3 BHKD, 3BHK & 2BHK are having car parking facilities in Cellar & Stilt floor. Parking facilities for towers comprises of 1 BHK are available only in Stilt level.
